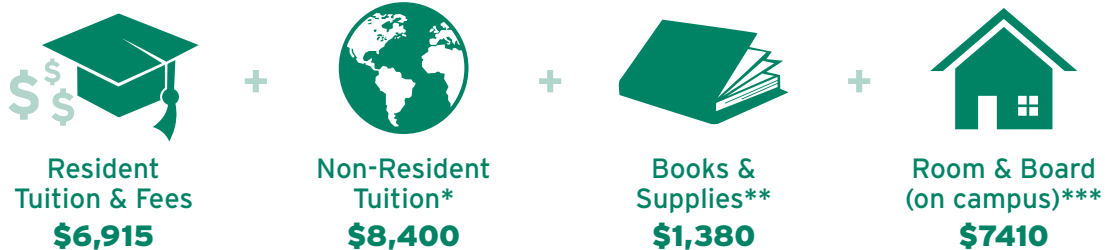


# OUT-OF-STATE NSU STUDENTS

## Financial Aid & Scholarships

Northeastern State University is Oklahoma's fourth-largest public institution, with three campuses and online programming. As the first institution of higher education in Oklahoma, we offer strong academics focused on career-readiness and the fourth-lowest tuition in the state! NSU offers 58 exceptional undergraduate and 26 graduate degree programs, as well as a professional degree in Optometry.

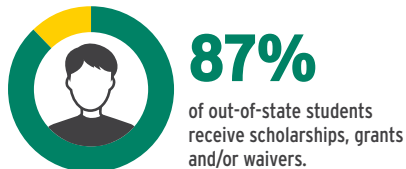
### FINANCIAL AID

In 2018-2019, NSU awarded over \$71 million in financial assistance in the form of scholarships, grants, part-time work, tuition waivers and education loans.

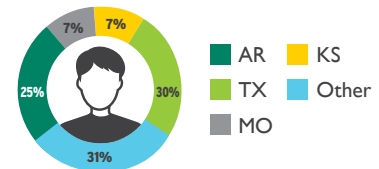

#### FALL 2019 (Out-of-State Students)



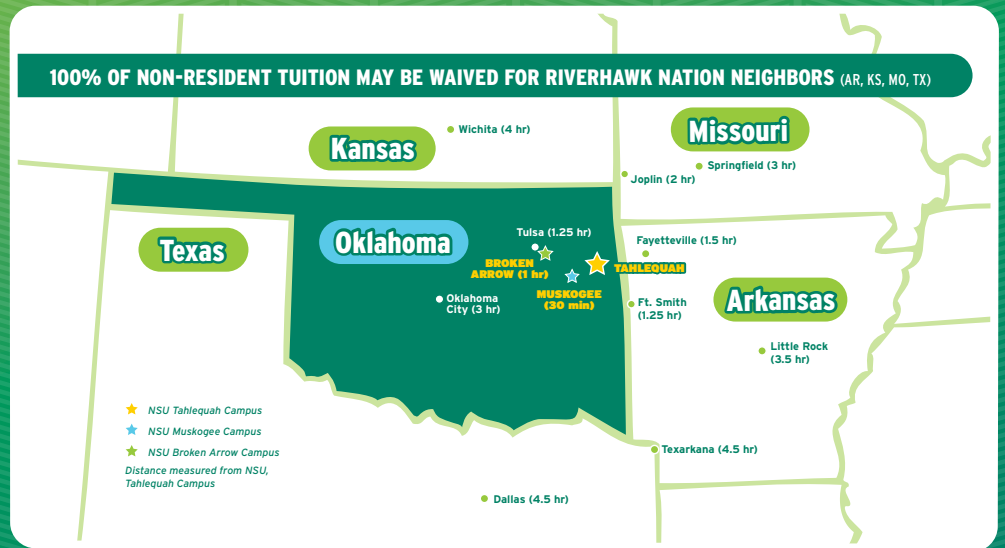

## 2023-2024 SCHOLARSHIPS

Incoming freshmen and transfer students may qualify for one of the following scholarships.



### QUAD STATE SCHOLARSHIPS

Incoming undergraduate students from Arkansas, Kansas, Missouri or Texas that meet regular admission requirements (not admitted alternatively or on probation) and live on campus, may be eligible for a scholarship waiving 100% of their nonresident tuition. Student's admitted alternatively or on probation can have their eligibility re-evaluated after their first semester at NSU. Non-resident tuition is \$280 per hour, in addition to in-state tuition. Students are still responsible for paying in-state tuition. This program waives only the non-resident portion. Legacy students whose parent, grandparent, or sibling earned a bachelor's or master's degree from NSU may receive the same benefits without the on-campus living requirement. Interested students must complete an Out-of-State scholarship application for the summer and fall semesters by Aug. 1 and for the spring semester by Jan. 1.

### NON-RESIDENT SCHOLARSHIPS

Incoming out-of-state students who are not residents of Oklahoma, Arkansas, Kansas, Missouri or Texas are also eligible for Out-of-State scholarships. Incoming freshmen that live on campus and have a minimum 3.0 unweighted GPA and a 25 composite ACT score may be eligible for a scholarship waiving 50% of their non-resident tuition. Transfer students that live on campus and have a minimum 2.75 GPA may be eligible for a scholarship waiving 50% of their non-resident tuition. Non-resident tuition is \$288 per hour, in addition to in-state tuition. Students are still responsible for paying in-state tuition. This program waives only a percentage of the non-resident portion. Legacy students whose parent, grandparent or sibling earned a bachelor's or master's degree from NSU may receive the same benefits without the on-campus living requirement. Interested students must complete an Out-of-State scholarship application for the summer and fall semesters by Aug. 1 and for the spring semester by Jan. 1.

### TRIBAL HERITAGE SCHOLARSHIPS

Students from states other than Oklahoma that meet regular admission requirements (not admitted alternatively or on probation) and are a member of a federally recognized tribe, may be eligible for a scholarship waiving 100% of the non-resident portion of their tuition. Non-resident tuition is \$288 per hour, in addition to in-state tuition. Students are responsible for paying in-state tuition. Interested students must complete an Out-of-State scholarship application for summer and fall semesters by Aug. 1 and for the spring semester by Jan. 1.

#### TUITION WAIVERS:

NSU awarded over \$6 million in tuition waivers last year! This scholarship waives a specified amount of a student's tuition costs. Fees are charged separately from tuition and are therefore not covered by this type of award.

#### HOUSING WAIVERS:

This scholarship waives a specified amount of a student's on campus housing costs.

#### FOUNDATION SCHOLARSHIPS:

The Foundation awarded \$875,101 in scholarships last year! These scholarships, including the Alumni Legacy Scholarship, are privately funded awards from NSU's Foundation. The money from these awards can apply towards any charges on a student's account. Simply fill out our General Scholarship Application to apply.

#### OUTSIDE SCHOLARSHIPS:

Money that comes from outside of NSU can be awarded in many different ways. Those donors have control over the way in which their money is applied and NSU will apply the funding accordingly.
