
FINANCIAL AID & SCHOLARSHIPS Helps Franch Your Education

In 2017-2018, NSU awarded over \$71 million in financial assistance in the form of scholarships, grants, part-time work, tuition waivers and education loans.

2019-2020 TUITION & FEES (In-State Tuition)

NSU has the lowest cost when compared with the three leading public residential four-year colleges in Oklahoma.



Last year, students saved more than \$875,000 by renting textbooks through the RiverHawk Shoppe.

Financial need and merit are the main factors considered for the awarding of grants and scholarships. "Merit-based" aid is awarded to students who do well in academics, leadership and community service. "Need-based" aid is given to students who lack the financial resources needed to go to college.

FINANCIAL AID

Complete the Free Application for Federal Student Aid (FAFSA) as soon as possible after Oct. 1.

You can sign up for your FSA I.D. and apply online at **fsaid.ed.gov**. State grants will be awarded on a first come, first serve basis starting Oct. 1 until funds are depleted.

Incoming Freshmen may qualify for one of the listed scholarships. These awards may also be stacked with Oklahoma's Promise funding. All scholarships are limited in number, therefore, students are encouraged to apply on or before the deadline.

Students can complete scholarship applications when they apply for admission to NSU. However, scholarships will NOT be awarded until a student has been admitted. Students MUST be admitted before the scholarship deadline.

Amounts may vary, depending on hours enrolled, and on campus living status.

Want an early scholarship decision?

Students that have been admitted and submit their freshmen general scholarship application before Dec. 2 may be eligible for an early scholarship decision. Decisions will be made and released before the end of December.

Incoming transfer students can receive one of the listed scholarships. These awards may also be stacked with Oklahoma's Promise funding. All scholarships are limited in number, therefore, students are encouraged to apply on or before the deadline. Students must be Oklahoma Residents to receive these awards. Students must be admitted by May 1 to be eligible for scholarships.

TYPES OF SCHOLARSHIPS:

Tuition Waivers:

NSU awarded over \$6 million in tuition waivers last year!
This scholarship waives a specified amount of a student's tuition costs. Fees are charged separately from tuition, and are therefore not covered by this type of award.

Foundation Scholarships:

The Foundation awarded \$873,772 in scholarships last year! These scholarships, including the Alumni Legacy Scholarship, are privately funded awards from NSU's Foundation. The money from these awards can apply towards any charges on a student's account.

Housing Waivers:

This scholarship waives a specified amount of a student's on campus housing costs,

Outside Scholarships:

Money that comes from outside of NSU can be awarded in many different ways. Those donors have control over the way in which their money is applied, and NSU will apply the funding accordingly.

Oklahoma's Promise:

This state funding is calculated according to NSU's tuition costs and the student's enrollment in any given semester. The awards are figured based on a student's cost of attendance and financial need. Funding from Oklahoma's Promise can be combined with NSU scholarships.
